CX Fuel Surcharges (Effective 16 May 2026) - Update

CX Fuel Surcharges will be revised for tickets issue / exchange on / after 16 May 2026 and travel on / after 16 May 2026.

Details :

1. The surcharge will be applied for ticket issue / exchange on / after 16 May 2026.

The application of fuel surcharge for tickets issue / exchange / re-issue as follows :

- For new tickets : New fuel surcharge applies
- For ticket re-issuance (Rebooking / Re-routing)
 - a) Totally un-used tickets (exchange) : New Fuel Surcharge apply
 - b) Partially used tickets (re-issue) : Applicable historical fuel surcharge apply based on the original ticket issue date

2. Historical fuel surcharge remains unchanged and will be carried for any ' Involuntary ' changes in ticket reissuance.

3. For CX flight coupons between HKG and South West Pacific, North America, Europe, Middle East, Africa.

between Japan and USA,

between USA / Spain and Brazil / Chile / Peru,

between Australia / New Zealand and Chile,

between United Kingdom / South Africa / France and Brazil,

between Qatar and Brazil / Croatia / Kenya / Russia / Serbia / Seychelles / South Africa / Ukraine.

POS worldwide for journey ex Japan : JPY 32,000 or equiv.

POS Hong Kong : HKD 1,362

POS Canada : CAD 237.70

POS New Zealand : NZD 294.00

POS elsewhere : USD 174.60 or equiv.

4. For CX flight coupons between HKG and South Asia Sub-Continent.

POS worldwide for journey ex Japan : JPY 15,000 or equiv.

POS Hong Kong : HKD 633

POS Canada : CAD 110.50

POS New Zealand : NZD 137.00

POS elsewhere : USD 81.20 or equiv.

5. For CX flight coupons not specified above :

POS worldwide for journey ex Japan : JPY 14,500 (for sector JP - TW / HK),
JPY 8,000 (for other sectors) or equiv.

POS worldwide for sector from Chinese mainland to Hong Kong : CNY135
from Hong Kong to Chinese mainland : HKD165 or equiv.

POS worldwide for journey ex Philippines : PHP 1958 (for sector between PH - HK)
USD 43.50 (for other sectors) or equiv.

**POS worldwide for journey ex Korea : USD50 (for sector between KR – HK)
USD 43.50 (for other sectors) or equiv.**

POS Hong Kong : HKD 339

POS Canada : CAD 59.20

POS New Zealand : NZD 73.00

POS elsewhere : USD 43.50 or equiv.

6. The surcharges apply per passenger per CX flight coupon and will be collected from all passengers regardless of ticket stock except

- a) Code-shared ferries / buses to / from HK on all CX sectors
- b) POS Bangladesh for journeys ex BD on all CX sectors
- c) POS worldwide for CX marketing flights within Japan.

7. The surcharge applies to all fare types and regardless of class of travel and type of fares including Frequent Flyer Program.

8. The surcharge is to be collected at point of sale and show as // YR // in the taxes / fees / charges box in the ticket.

9. There is no exemption to any category of passengers (such as children / infants / senior / AD / FOC... etc. For ID, please refer to carrier), except infant without seat is exempted for POS PH, ex PH, sector between PH - HK.
10. The surcharge is interlinable and the amount shall accrue to CX .
11. For ticket cancellations, the residual of fare will offset the refund handling fee and / or local refund administrative fee only. Fuel surcharge will not be used to offset the cancellation penalty.
12. The surcharge will apply until further notice.
